Error Corrections

PPVT-4/5

Because Pearson will no longer support PPVT-4 on the iPad version, sites using the iPad must choose whether to use paper forms for the PPVT-4 or switch to the PPVT-5. For 2023-24, PPVT-4 data will be included in processed datasets. FPG's website will accept PPVT-5 data but will not be updated to confirm scores for the PPVT-5 nor will PPVT-5 data be included in processed datasets. You can request paper PPVT-4 forms from Linda Soto at FPG

LEP-NEP Community of Practice - 9/8/23

Allison DeMarco led the group in continuing to thinking about building a culture of accountability by walking through a logic model toward DEIB goals. LEPs worked in the same small groups as the August meeting and debriefed with the whole group afterward.
